ENAKMEN PENTADBIRAN AGAMA ISLAM
(NEGERI SELANGOR) 2003PERATURAN-PERATURAN PENDAFTARAN, PENJAGAAN DAN PENGAJARAN BAGI
MUALLAF (NEGERI SELANGOR) (PINDAAN) 2017

PADA menjalankan kuasa yang diberi oleh perenggan 122(2)(i) Enakmen Pentadbiran Agama Islam (Negeri Selangor) 2003 [*Enakmen No. 1/2003*], Majlis Agama Islam Selangor, dengan kelulusan Duli Yang Maha Mulia Sultan, membuat peraturan-peraturan yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Peraturan-peraturan ini bolehlah dinamakan **Peraturan-Peraturan Pendaftaran, Penjagaan dan Pengajaran bagi Muallaf (Negeri Selangor) (Pindaan) 2017**.

(2) Peraturan-Peraturan ini mula berkuat kuasa pada 1 April 2017.

Pindaan peraturan 2

2. Peraturan-Peraturan Pendaftaran, Penjagaan dan Pengajaran bagi Muallaf (Negeri Selangor) 2009 [*Sel. P.U. 14/2009*], yang disebut "Peraturan-Peraturan ibu" dalam Peraturan-Peraturan ini, dipinda dalam peraturan 2 dengan menggantikan takrif "Jabatan" dengan takrif yang berikut—

‘ “Jabatan” ertinya suatu jabatan atau bahagian dalam Majlis atau mana-mana badan atau agensi yang diberi kuasa oleh Majlis untuk menguruskan hal ehwal muallaf; ’.

Pernomboran semula peraturan 34A

3. Peraturan 34A Peraturan-Peraturan ibu dipinda dengan menomborkan semula peraturan itu sebagai peraturan 35 Peraturan-Peraturan ibu.

Peraturan 34A Baru

4. Peraturan-Peraturan ibu dipinda dengan memasukkan selepas peraturan 34 peraturan yang berikut:

“Kuasa Majlis

34A. Majlis boleh melantik Pemegang Amanah Lembaga Zakat Selangor (MAIS), Berdaftar atau mana-mana orang bagi menjalankan kuasa Majlis

di bawah Peraturan-Peraturan ini yang berhubungan dengan bantuan, perlindungan, bimbingan, pusat bimbingan dan tenaga pengajar bagi muallaf yang ditadbir di bawah Peraturan-Peraturan ini.”.

REGISTRATION, CARE AND TEACHING FOR MUALLAFS (STATE OF
SELANGOR) (AMENDMENT) REGULATIONS 2017

IN exercise of the powers conferred by paragraph 122(2)(i) of the Administration of the Religion of Islam (State of Selangor) 2003 [*Enactment No. 1/2003*], the Majlis Agama Islam Selangor, with the consent of His Royal Highness the Sultan, make the following regulations:

Citation and commencement

1. (1) These regulations may be cited as the **Registration, Care and Teaching for Muallafs (State of Selangor) (Amendment) Regulations 2017**.

(2) These Regulations come into operation on 1 April 2017.

Amendment of regulation 2

2. Regulation 2 of the Registration, Care and Teaching for Muallafs (State of Selangor) Regulations 2009 [*Sel. P.U. 14/2009*], which in these Regulations are referred to as the “principal Regulations” is amended by substituting for the definition of “Department” the following definition—

‘ “Department” means a department or division of the Majlis or any body or agency which is authorized by the Majlis to manage the affairs of muallafs; ’.

Renumbering of regulation 34A

3. Regulation 34A of the principal Regulations is amended by renumbering the regulation as regulation 35 of the principal Regulations.

New regulation 34A

4. The principal Regulations are amended by inserting after regulation 34 the following regulation:

“The power of Majlis

34A. Majlis may appoint the Trustees of Lembaga Zakat Selangor (MAIS), Registered or any person to carry out the powers of the Majlis under these Regulations relating to assistance, protection, guidance, guidance centre and teaching staff for muallafs which are governed under these Regulations.”.
